

Are You Urban Beachy Keen? Online Survey Competition

Conditions of Entry

1. The promoter of the Are You Urban Beachy Keen? Online Survey Competition ("Competition") is the Urban Renewal Authority (trading as Renewal SA) of Level 9, Riverside Centre, North Terrace, Adelaide, SA 5000 ("Promoter").

Entry

2. Information on how to enter the Competition forms part of these terms and conditions ("Conditions of Entry"). By submitting an entry into the Competition, all Entrants fully and unconditionally agree to and accept these Conditions of Entry.
3. Entrants must be eighteen years of age or older, a resident of South Australia, and satisfy the entry requirements as stated in clause 4. The officers, management and employees (or immediate family of an officer, manager or employee) of the Promoter, the agencies associated with this Competition, and their related bodies corporate are not eligible to enter.

5. The Competition starts at 10.00am on Wednesday, 31/01/2018 and ends at 10.00am on Wednesday, 14/02/2018 ("Competition Period").
6. Entries are free. Only one entry per person is permitted. An entrant can only win once during the Competition Period.
7. All materials and Competition entries are the property of the Promoter. On receiving a prize from the Competition, Entrants license the Promoter to use their entry content across its channels in any manner the Promoter wishes (including modifying, adapting, copying, publishing, broadcasting or communicating the entry, whether in original or modified form, in whole or in part or not at all), by way of all media, in perpetuity, without payment to the Entrant (of royalties, compensation or otherwise). Prize(s)

Conditions of Entry

The Promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alterations of entries, and reserves the right to take any action that maybe available.
